ORDINANCE NO. 25-1361

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY, MOHAVE COUNTY, ARIZONA, AMENDING LAKE HAVASU CITY CODE CHAPTER 2.04, CITY ORGANIZATION AND CITY COUNCIL, SECTION 2.04.080, REGULAR MEETINGS, TO REVISE MEETING LOCATION AND SECTION 2.04.130, EXECUTIVE SESSIONS, TO CLARIFY MEETING TYPE

IT IS ORDAINED, by the Mayor and City Council of Lake Havasu City, Arizona, as follows:

<u>Section 1</u>: That Lake Havasu City Code Section 2.04.080, Regular Meetings, is amended to revise the meeting location as follows:

§ 2.04.080 REGULAR MEETINGS.

The Council shall hold regular meetings on the second Tuesday and the fourth Tuesday of each month at 5:30 p.m.; provided, that when the day fixed for any regular meeting of the Council falls upon a day designated by law as a legal holiday, or if 4 or more members of the Council contemplate that they will be unavailable for a regular meeting and so notify the City Clerk of their anticipated absence at least 7 days prior to the regular meeting, or if there are no items for Council consideration, the meeting will not be held and may be rescheduled to a date certain. The City Clerk, when so notified in accordance with the above provisions, shall cause to be posted in 3 or more public places the fact that the regular meeting in question will not be held. Additionally, the City Clerk shall cause a notice to be published in a local newspaper of general circulation, to appear prior to the regular meeting in question, wherein it shall state that the regular meeting will not be held. All regular meetings of the Council shall be held at the Lake Havasu City Police Facility, 2360 McCulloch Boulevard MUNICIPAL COURT/COUNCIL CHAMBERS, 92 ACOMA BOULEVARD SOUTH, Lake Havasu City, or at such other place as may be designated by the Council from time to time.

<u>Section 2</u>: That Lake Havasu City Code Section 2.04.130, Executive Sessions, is amended to clarify any meeting as follows:

§ 2.04.130 EXECUTIVE SESSIONS.

- A. An executive session of the City Council may be scheduled as requested in accordance with § 2.04.280 or by the City Manager or City Attorney, by notifying the members of the Council and the public of the executive session in accordance with the Arizona Open Meeting law.
- B. <u>DURING ANY COUNCIL MEETING</u>, the Council may vote during any regular or special meeting to meet in executive session to receive legal advice on any matter listed on the agenda pursuant to A.R.S. § 38-431.03.

Section 3: All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are repealed.

<u>Section 4</u>: If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
