

**A LISTING OF WATER DIVERTERS, WELL NUMBERS OR POINT(S) OF  
DIVERSION, AND POINTS OF RETURN WITHIN THE LAKE HAVASU CITY  
CONTRACT SERVICE AREA**

1. This Exhibit C, Revision 2, made this \_\_\_\_ day of \_\_\_\_\_, 2025, to be effective under and as part of Contract No. 3-07-30-W0039, dated October 4, 1995, hereinafter called "Contract," shall become effective on the date of its execution and supersedes Exhibit C, Revision 1, dated March 31, 2006. This Exhibit C, Revision 2 shall remain in effect until superseded by another Exhibit C executed by the Parties; Provided, That this Exhibit C, Revision 2 or any superseding Exhibit C shall terminate with the termination of the Contract.
2. The points of diversion for Mainstream Water delivered pursuant to this Contract are listed in this Exhibit C, Revision 2, which identifies wells within the Lake Havasu City Contract Service Area that have been determined to be currently diverting, or have the potential to divert in the future, Mainstream Water that are subject to the reporting requirements under Section 11 of this Contract, unless exempted by or as otherwise directed by the Contracting Officer in writing. Upon the Contracting Officer's determination that a point of diversion listed in this Exhibit C, Revision 2 is not Mainstream Water, and therefore not subject to the reporting requirements under Section 11 of this Contract, such determination will be attached to and deemed to be part of Exhibit C of the Contract.
3. There are currently no surface points of return located within the Lake Havasu City Contract Service Area.
4. Lake Havasu City will notify the Contracting Officer of any changes in points of diversion or points of return for Mainstream Water under the Contract. Lake Havasu City will provide this notification by a letter to the Contracting Officer no later than January 31 following any year in which Lake Havasu City makes such additions, changes, or deletions. If the Contracting Officer approves the request for changes in points of diversion or points of return for Mainstream Water, the Contracting Officer will notify Lake Havasu City in writing. Upon the Contracting Officer's approval of any requested changes in points of diversion or points of return for Mainstream Water, the letter from Lake Havasu City listing the additions, changes, or deletions to points of diversion or points of return for Mainstream Water will be attached to and deemed to be part of this Exhibit C.
5. Lake Havasu City shall provide additional information on all points of diversions including wells, or points of return flow when requested by the Contracting Officer.
