Oracle Cloud HCM Cloud Time & Labor, Payroll & ERP Support – Statement of Work Addendum

1. This amendment is between Camptra Technologies LLC, acting as a provider ("Camptra") and Lake Havasu City, acting as a client ("LHC"), parties to the agreement Oracle Cloud HCM Cloud Time & Labor, Payroll, & ERP Support dated 7/01/2022 (the "Agreement").

2. The Agreement is amended as follows:

Section 1 Support Overview

A clause binding the Agreement to the Master Service Agreement has been added, Section 1 is replaced in its entirety and now reads as follows:

This Statement of Work is between Camptra Technologies LLC, acting as a provider ("Camptra") and Lake Havasu City, acting as a client ("LHC" or "Client") for the support on multiple modules of the Oracle Cloud HCM Payroll and ERP Cloud Suite products. This Statement of Work will be governed by and subject to the terms and conditions set forth and agreed upon by LHC and Camptra under the Master Agreement dated April 1st, 2020, ("the MSA").

This SOW will be effective from July 1st, 2022

Section 10.1 – Services

An additional 700 hours have been added to the budget (initially the budget was 500 hours), section 10.1 is updated to reflect this new amount:

The activities are on a time and materials basis. Activities performed will be as per the scope stated in **Section 3 Scope of Services**. Estimated professional service fee quotes are valid for 30 days from date of SOW. The effort estimated for the engagement is estimated at **1,200 hours total**.
