

**ORDINANCE NO. 24-1330**

**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY, MOHAVE COUNTY, ARIZONA, DECLARING THE DOCUMENT ENTITLED “2024 AMENDMENTS TO THE LAKE HAVASU CITY CODE TITLE 4, WATER AND WASTEWATER REGULATIONS, APRIL 23, 2024” A PUBLIC RECORD AND ADOPTING BY REFERENCE WATER AND WASTEWATER REGULATIONS AND PENALTIES, INCLUDING SERVICE, BILLING, CONNECTIONS, CHARGES, HYDRANT METERS, PRIVATE FIRE PROTECTION SERVICES, AND BACKFLOW PREVENTION; AND REPEALING LAKE HAVASU CITY CODE CHAPTERS 8.05 AND 8.20 AND SECTIONS 11.04.280 AND 11.04.290, TO AMEND AND CONSOLIDATE ALL WATER AND WASTEWATER REGULATIONS INTO TITLE 4**

**IT IS ORDAINED**, by the Mayor and City Council of Lake Havasu City, Arizona, as follows:

**Section 1:** That Title 4 of the Lake Havasu City Code, currently reserved, is amended as shown on the attached Exhibit “A” entitled the “2024 Amendments to the Lake Havasu City Code Title 4, Water and Wastewater Regulations, April 23, 2024,” which is adopted and incorporated into this Ordinance by reference.<sup>1</sup>

**Section 2:** That Chapter 8.05, Public Sewers, of the Lake Havasu City Code is repealed.

**Section 3:** That Chapter 8.20, Backflow Prevention and Cross Connection Control, of the Lake Havasu City Code is repealed.

**Section 4:** That Section 11.04.280, Adoption of Irrigation and Drainage District Rules and Regulations by Reference, of the Lake Havasu City Code is repealed.

**Section 5:** That Section 11.04.290, Penalties For Violation of Lake Havasu City’s Irrigation and Drainage Code, of the Lake Havasu City Code is repealed.

**Section 6:** All ordinances or parts of ordinances in conflict with the provisions of this Ordinance or any part of the City Code adopted herein by reference, are repealed.

**Section 7:** If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
