

## **RESOLUTION NO. 25-3849**

### **A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY, MOHAVE COUNTY, ARIZONA, APPROVING THE SUBMISSION OF GRANT APPLICATIONS TO THE U.S. DEPARTMENT OF TRANSPORTATION, SAFE STREETS AND ROADS FOR ALL PROGRAM, AND THE ARIZONA DEPARTMENT OF TRANSPORTATION, AZ SMART PROGRAM, FOR THE INSTALLATION OF TRAFFIC SIGNAL BACKPLATES, AND AUTHORIZING EXECUTION OF NECESSARY DOCUMENTS AND IMPLEMENTATION OF THE ACTIVITIES FUNDED BY THE GRANT**

**RECITALS:** Lake Havasu City (“City”) is authorized under Arizona Revised Statutes § 11-952 to enter into intergovernmental agreements. The United States Department of Transportation administers the Safe Streets and Roads for All (“SS4A”) Program that funds regional, local, and Tribal initiatives through grants to prevent roadway fatalities and serious injuries. The Arizona Department of Transportation administers the State Match Advantage for Rural Transportation (“AZ SMART”) Fund, which assists eligible cities to compete more effectively at the national level for federal grants. Eligible projects include surface transportation projects that have been awarded, or will be submitted for, a federal grant. The City desires to apply for both the federal SS4A grant and match funding under the AZ SMART Program to install new traffic signal head backplates with retroreflective borders at all signalized intersections within Lake Havasu City. The project includes 33 signalized intersections (20 ADOT signals and 13 City signals).

**IT IS RESOLVED** that the Mayor and City Council of Lake Havasu City approve the submission of grant applications to the United States Department of Transportation, SS4A Program, and the Arizona Department of Transportation, AZ SMART Program; and authorize the City Manager to execute the grant agreements, deliver all documents necessary to carry out the terms and intent of the grants, and take all steps necessary to implement and complete the activities funded and required by the grants, subject to necessary review and approval by the City Attorney.
