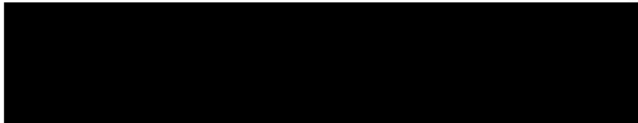
Flow Chart for SummeRay Wine Bar & Local Eatery
