STATEMENT OF WORK
FOR
SUBSTANCE ABUSE, BEHAVIORAL HEALTH TREATMENT AND PEER SUPPORT
SERVICES

1. Provider shall perform the following work:

(a) Substance Abuse and Behavioral Health Treatment Services:

I. Provide substance abuse and behavioral health treatment services for participants in the co-occurring Building Bridges Court. Building Bridges Court is a co-occurring court. It is a specialized problem-solving court designed to address cases involving individuals who have both a mental health disorder and a substance use disorder—often referred to as "dual diagnosis" or "co-occurring disorders." These courts aim to provide a more holistic, therapeutic approach to justice, rather than relying solely on punitive measures.

- 1) Perform assessments and provide recommended services.
- 2) Provide services to improve wellness, manage and/or reduce substance abuse and behavior/mental health symptoms.
- 3) Provide substance abuse and behavior health treatments services that includes group and individual therapy, MAT services, in-patient and out-patient services and recovery workshops.
- 4) Provide support groups.
- 5) Provide statical reports as requested.
- 6) Provide a minimum of twenty (20) hours of case management and twenty (20) hours of treatment for each participant.
- 7) Attend established monthly staffing's to review cases and make treatment and/or service adjustments
- 8) Attend established quarterly meetings to discuss new treatment options, concerns, and internal improvements.

(b) Substance Abuse and Behavioral Health Treatment Services:

- 1) Provide Peer Support Services for participants in the co-occurring Building Bridges Court.
 - 1) Provide services to Building Bridges Court participants.
 - 2) Provide assistance and referrals to housing, employment, education, social and religious support, healthcare, crisis intervention, medical services, transportation, anger management, couple counseling, domestic violence offender treatment, parenting classes, financial classes and workbooks.
 - 3) Provide support in Court events and transportation.
 - 4) Provide support groups.
 - 5) Provide up to 90 hours of peer support services for each Building Bridges Court participant.
 - 6) Attend established monthly staff meetings to review cases and make treatment and/or services adjustments.
 - 7) Attend established quarterly meetings to discuss new treatment options, concerns, and internal improvements.

2. The maximum payment under this Contract, including expenses, is:

"Not-to-Exceed" the amount of \$50,000 annually as per the rates listed in Exhibit 5.

3. City shall pay Provider on the following basis:

City shall make payment to Provider within thirty (30) days from the time of invoice, provided the Provider submits an invoice that meets the City's accounting level standards pursuant to City requirements.

4. Provider will bill City for the work as follows:

Provider shall provide an invoice for services completed during the latest monthly billing period. Invoice process will continue until services are complete and combined invoice amounts do not exceed the maximum payment pursuant to item 2 listed above.
