Dear Property Owner,

Lake Havasu City initiated a process to determine if the City owned property, described as Tract 2211, Block 2, Parcel B, is still necessary for government use. The property is zoned Commercial Southgate (C-SGD) District and measures 20 feet by 250 feet. Upon completion of our review, Staff has determined the property is no longer needed for public use.

Applying a per square-foot formula, a value of \$50,000 has been assessed to this property. Typically, the property would be split into two identical 10 x 250-foot properties with each half offered for sale to the adjacent property owner. If one of the owners does not express interest in that half of the property, the entire parcel will be offered to the other adjacent owner.

This letter is to determine your interest as an adjacent owner to purchase half the property at our assessed value. The value of a 10' x 250' half portion of this commercial property is \$25,000. Additionally, a \$860.63 application fee shall be paid to the city, and any closing costs and fees for the sale will be paid directly from the purchaser to the title company.

If you are interested in purchasing the property, please sign and notarize this letter and return the original notarized document to our office no later than October 1, 2022. Once the affidavit is received, our office will contact you for the Sale of Public Property Application fee of \$860.63 per property half.
