This Agreement is effective as of the date of the Mayor's signature below, and shall continue in effect through April 7, 2017. Either Party may terminate this Agreement without cause upon ten (10) days' written notice directed to the other Party. Any required insurance and indemnification shall survive termination of this Agreement. City may terminate this Agreement immediately upon Service Provider's breach of any term of this Agreement.
- 2. Service Provider agrees to provide the services as described in Exhibit "A." Service Provider must have and maintain for the duration of this Agreement a valid City Business License, if applicable.
- 3. Each Party (as "Indemnitor") agrees to indemnify, defend, save, and hold harmless the other Party (as "Indemnitee") from and against any and all claims, actions, liabilities, damages, costs, losses or expenses (including but not limited to, court costs, attorneys' fees, and costs of claim processing, investigation, and litigation) to which any Indemnitee may become subject, under any theory of liability ("Claims") arising out of bodily injury of any person (including death) or property damage, but only to the extent that such Claims which result in vicarious/derivative liability to the Indemnitee are caused by the act, omission, negligence, misconduct, or other fault of the Indemnitor, its owners, officers, directors, officials, agents, employees, contractors, or volunteers.
- 4. This Agreement may not be assigned or subcontracted by Service Provider without the written approval of the City, which approval may be withheld. Should Service Provider violate this provision, the City may declare this Agreement immediately terminated.
- 5. This Agreement may be cancelled pursuant to Arizona Revised Statutes ("ARS") § 38-511.
- 6. If, applicable, Service Provider warrants compliance with ARS § 41-4401 and that it is compliant with all federal immigration laws. Breach of this section is a material breach of this Agreement.
- 7. If applicable, Service Provider shall comply with ARS §§ 1-501 and 1-502 with regard to demonstrating lawful presence in the United States when applying to receive a public benefit.
- **8.** This Agreement may be signed in duplicate originals for the purpose of providing each party with a completely executed original.

9. Service Provider certifies that it is not currently engaged in, and agrees for the duration of this Agreement that it will not engage in, a boycott of Israel, as that term is defined in A.R.S. § 35-393.
