A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY, MOHAVE COUNTY, ARIZONA, DECLARING AND ADOPTING THE OFFICIAL CANVASS OF THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 30, 2016

RECITALS: Lake Havasu City, Arizona, held a Primary Election on Tuesday, August 30, 2016, for the purpose of nominating candidates for the November 8, 2016, General Election. Any candidate who receives at the Primary Election, a number of votes constituting a majority of all the votes cast, shall be declared to be elected to the office for which that person is a candidate effective as of the date of the General Election. Notice of the Election was duly and regularly given in time, form, and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast and received and the returns made and declared in the time, form and manner required by the provisions of state election law for the holding of elections in cities. It now becomes the duty of the City Council of Lake Havasu City, Arizona, to canvass the returns of the election and declare the results thereof.

IT IS RESOLVED that the Mayor and the City Council of Lake Havasu City, Arizona, declare the results of the Primary Election held on August 30, 2016, as follows:

<u>Section 1</u>: That the total number of ballots cast at each precinct and the number of votes cast in the City for the candidates are listed in the attached Exhibit "A," which is declared and adopted as the Official Canvass.

<u>Section 2</u>: That the total number of ballots cast in the Lake Havasu City Primary Election was 10,942.

<u>Section 3</u>: That the votes cast for Councilmember at the Lake Havasu City Primary Election were as follows:

<u>Section 5</u>: That it is found, determined, and declared of record, that two (2) Councilmember seats were filled in the Primary Election, and that a General Election will be held on November 8, 2016, to elect one (1) Councilmember. The candidates who received the highest number of votes shall have the right to have their names placed upon the official ballot to be voted upon at the General Election. The City Clerk is directed to place on the official ballot the names of each of these two (2) candidates for the office of Councilmember:
