

## ORDINANCE NO. 16-1164

### AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY, MOHAVE COUNTY, ARIZONA, AMENDING LAKE HAVASU CITY CODE SECTION 11.08.220, FINANCIAL RESPONSIBILITY, OF THE AIRPORT OPERATION REGULATIONS CHAPTER

IT IS ORDAINED, by the Mayor and City Council of Lake Havasu City, Arizona, as follows:

**Section 1:** Lake Havasu City Code Section 11.08.220, Financial Responsibility, is amended as follows:

#### **§ 11.08.220 Financial Responsibility**

~~A.—All owners of aircraft regularly situated~~ BASED at the airport MORE THAN NINETY (90) DAYS IN A CALENDAR YEAR must PROVIDE PROOF OF INSURANCE UPON REQUEST. THE NINETY (90) DAYS IS TOTAL TIME AT THE AIRPORT AND NEED NOT BE CONSECUTIVE. ~~shall be financially responsible. Any such owner shall, upon request, furnish the city with evidence of financial responsibility. The minimum financial responsibility required pursuant to this section shall be as follows:~~

- ~~—1. Bodily injury or death, including occupants of aircraft, 1 person—\$50,000.~~
- ~~—2. Bodily injury or death, excluding occupants of aircraft, 2 or more persons—\$300,000.~~
- ~~—3. Property damage \$300,000.~~

~~—B. Evidence of financial responsibility shall consist of a certificate of insurance or a bond issued by an insurance company or a surety company duly authorized to transact business in the state.~~

~~—C. If the owner of an aircraft regularly situated at the airport fails or refuses to furnish the city with the required evidence of financial responsibility when so requested, the owner shall thereafter be prohibited from basing any aircraft which he or she may own at the airport until such time as he or she complies with the provisions of this section.~~

**Section 2:** All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

**Section 3:** If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
