## ADDENDUM NO. 1 TO INTERGOVERNMENTAL AGREEMENT BETWEEN LAKE HAVASU CITY AND MOHAVE COUNTY Joint Road Maintenance 2015-2035

THIS ADDENDUM NO. 1 TO INTERGOVERNMENAL AGREEMENT ("Addendum") is entered into this \_\_\_\_\_ day of \_\_\_\_\_\_, 2016, in accordance with Arizona Revised Statutes §§ 11-951 through 11-954, by and between Lake Havasu City, an Arizona municipal corporation, acting by and through its City Council, ("City"), and Mohave County, a political subdivision of the State of Arizona, acting by and through its Board of Supervisors, ("County"), both individually referenced as the "Party" and collectively referenced as the "Parties." The Parties agree as follows:

**RECITALS,** City and County entered into an Intergovernmental Agreement for Joint Road Maintenance on June 6, 2015 ("Agreement"). As part of City's Wayfinding Project, City desires to amend the Agreement to incorporate the installation and maintenance of three (3) future wayfinding signs along certain County roads.

## 1. <u>Section B of the Agreement is amended to include new subsections (5) and (6) as follows:</u>

## B. <u>City Responsibilities</u>:

5. City will install and maintain three signs as part of its Wayfinding Project along County roads as shown on the attached Exhibit C ("Wayfinding Signs"). Two (2) Wayfinding Signs will be placed in the right-of-way of London Bridge Road directly north and south of Fathom Drive and one (1) Wayfinding Sign will be placed in the right-of-way on Fathom Drive just east of Reef Boulevard.

6. City will ensure Wayfinding Signs installation and maintenance adheres to the standards set forth in the latest edition of the Manual on Uniform Traffic Control Devices.

## 2. <u>Section C of the Agreement is amended to include a new subsection (5) as follows:</u>

#### C. <u>County Responsibilities</u>:

5. County agrees to allow City to install and maintain the Wayfinding Signs along the County roads as described above and shown on the attached Exhibit C.

#### 3. <u>Reaffirmation of Unamended Provisions to Agreement:</u>

All other sections and provisions of the Agreement not amended or restated by this Addendum No. 1 shall remain in full force and effect and shall be considered reaffirmed by the execution of this Addendum.
