

RESOLUTION NO. 18-3262

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY, MOHAVE COUNTY, ARIZONA, DECLARING AND ADOPTING THE OFFICIAL CANVASS OF THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 28, 2018

RECITALS: Lake Havasu City, Arizona, held a Primary Election on Tuesday, August 28, 2018, for the purpose of nominating candidates for the November 6, 2018, General Election, and submitting a question to propose a permanent base adjustment to the 1979-1980 Base Expenditure Limitation for Lake Havasu City. Any candidate who receives at the Primary Election a number of votes constituting a majority of all the votes cast shall be declared to be elected to the office for which that person is a candidate effective as of the date of the General Election. Notice of the Election was duly and regularly given in time, form, and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes were cast and received and the returns made and declared in the time, form and manner required by the provisions of state election law for the holding of elections in cities. It now becomes the duty of the City Council of Lake Havasu City, Arizona, to canvass the returns of the election and declare the results thereof.

IT IS RESOLVED that the Mayor and City Council of Lake Havasu City, Arizona, declare the results of the Primary Election held on August 28, 2018, as shown by the Election Summary Report as presented by the Mohave County Elections Department attached as Exhibit "A," which is declared and adopted as the Official Canvass, as follows:

Section 1: That the total number of ballots cast in the Lake Havasu City Primary Election was 13,891.

Section 2: That the total percentage voting in the Lake Havasu City Primary Election was 39.4%.

Section 3: That the votes cast for Mayor at the Lake Havasu City Primary Election were as follows:

Section 5: That the votes cast for Proposition 409 (Permanent Base Adjustment) at the Lake Havasu City Primary Election were as follows:

Section 7: That it is found, determined, and declared of record, that the question to propose a permanent base adjustment to the 1979-1980 Expenditure Limitation for Lake Havasu City passed by the electors of Lake Havasu City.

Section 8: That it is found, determined, and declared of record that all seats were filled in the Primary Election, and that a General Election will not be held on November 6, 2018.

Section 9: That all successful candidates in the Primary Election will take office on November 27, 2018.
