

**ORDINANCE NO. 19- 1215**

**AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF LAKE HAVASU CITY,  
MOHAVE COUNTY, ARIZONA, AMENDING LAKE HAVASU CITY CODE  
CHAPTER 11.06, PARKS AND RECREATION, REGARDING STUDENT MEMBER,  
BOARD REQUESTS, AND CHANGES FROM COMMUNITY SERVICES TO PARKS  
AND RECREATION**

**IT IS ORDAINED**, by the Mayor and City Council of Lake Havasu City, Arizona, as follows:

**Section 1:** That Lake Havasu City Code Section 11.06.021, Appointment of Student Body Member, is deleted in its entirety.

**§ 11.06.021 APPOINTMENT OF STUDENT BODY MEMBER.**

~~The Mayor shall solicit from the principal of Lake Havasu High School the names of not less than 5 students at the school prior to making the appointment provided for at § 11.06.020(C). If such list is provided within 30 days of the Mayor's request therefor, appointment shall be made from the list; otherwise, the Mayor shall appoint such member of the student body as he or she deems fit.~~

**Section 2:** That Lake Havasu City Code Section 11.06.040, Department Oversight, is amended as follows:

**§ 11.06.040 DEPARTMENT OVERSIGHT.**

The ~~Community Services~~ PARKS AND RECREATION Department shall oversee the Parks and Recreation Advisory Board.

**Section 3:** That Lake Havasu City Code Section 11.06.070, Powers and Duties, is amended as follows:

**§ 11.06.070 POWERS AND DUTIES.**

A. The Parks and Recreation Advisory Board shall have the following powers and duties:

1. To set a time for regular meetings which shall be held at least once each month if there is business to transact, whereby 5 members shall constitute a quorum for the transaction of business;

2. To organize by electing a Chairperson and a Vice-Chairperson;

~~—3. To advise and consult, through the Chairperson of the Board, with the Community Services Department as to the items to be included upon the agenda of meetings of the Board prior to the preparation and distribution of the agenda by the Community Services Department;~~

34. To review and approve the official minutes of all Board meetings as prepared by the ~~Community Services~~ PARKS AND RECREATION Department prior to the transmittal of such minutes to the City Council;

45. To assist and advise the City Council and City Manager in the establishment of essential policies, rules, and regulations relating to the planning, acquisition, disposition, operation, use, care, and maintenance of areas and structures owned, leased, or otherwise acquired by the city for use as parks and/or recreational centers;

56. To assist and advise the ~~Community Services~~ PARKS AND RECREATION Director in the development of a continuing plan for the city's park system and recreation programs. The City Manager, through the ~~Community Services~~ PARKS AND RECREATION Director, shall from time to time send such plans and programs to the Board for review. The results of such reviews shall be forwarded to the City Council;

67. To assist and advise the ~~Community Services~~ PARKS AND RECREATION Director in establishing priorities at budget time for those items, other than administrative functions, relating to park acquisition and development and recreational and leisure programming. The recommendations of the Board shall be forwarded to the City Council by the City Manager when he or she submits the proposed budget to the Council.

78. To receive, accept, and acquire, subject to final action by the City Council, by gift, bequest, or devise real and/or personal property of any and every kind, nature and description in the name of the city for park and/or recreational purposes, subject to the terms of the gift;

89. To suggest to the Mayor and City Council qualified and interested persons eligible for appointment to vacancies on the Board;

94~~0~~. To prepare and recommend to the City Council for approval a master plan for the development of municipally owned parks and a specific plan for the development of each city park.

**Section 4:** That Lake Havasu City Code Section 11.06.200(A)(2), Definitions, *Director*, is amended as follows:

**§ 11.06.200 DEFINITIONS.**

A. In this article, the following words and phrases shall have the following meanings in this chapter:

2. DIRECTOR. The ~~Community Services~~ PARKS AND RECREATION Director. Powers and duties delegated to the Director pursuant to the provisions of this article may be exercised or discharged by any person so delegated by the Director.

**Section 5:** That Lake Havasu City Code Section 11.06.210(C)(4), Use By Groups – Permit Required, is amended as follows:

**§ 11.06.210 USE BY GROUPS—PERMIT REQUIRED.**

C. In addition to the permit required by this section, a group shall be required to obtain the permit required by § 9.20.020 if any of the following circumstances or conditions pertain:

4. The activity planned by the group requires, in the opinion of the Director, the services or permits provided by a department of this city other than the ~~Community Services~~ PARKS AND RECREATION Department.

**Section 6:** All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are repealed.

**Section 7:** If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
