



**AMENDMENT NO. 2 TO THE SERVICES AGREEMENT BETWEEN LAKE HAVASU CITY
AND CHERRYROAD TECHNOLOGIES INC. DATED NOVEMBER 28, 2017**

This Amendment No. 2 to Services Agreement dated November 28, 2017 ("Amendment") is entered into as of March 12th, 2019 ("Effective Date") by and between Lake Havasu City ("City") and CherryRoad Technologies Inc. ("CherryRoad"), together ("the Parties").

RECITALS: The Parties entered into a Services Agreement dated November 28, 2017 ("Agreement") and an Amendment No. 1 to the Services Agreement dated May 23, 2018 ("Amendment No. 1"). The City requested additional services related to the ERP System Implementation Services and this Amendment is necessary to add those services into the Scope of Work ("SOW") contained in the Agreement and Amendment No. 1. The additional services are listed on the attached "Attachment 1: Functional Requirements / Lake Havasu City" and incorporated herein.

NOW, THEREFORE, the Parties, agreeing that it is necessary to modify the Agreement and Amendment No. 1, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Parties, hereby amend the Agreement and Amendment No. 1 as follows:
