### **Citizen Participation Report**

### **Purpose:**

The purpose of the Citizen Participation Report is to provide the City of information regarding the efforts completed by the Applicant to inform citizens and property owners in the vicinity about the Applicant's proposed development.

The proposal is for a Planned Development Amendment of approximately 10-acres of vacant land located at the northwest corner of Highway I-95 and London Bridge Road. This project will accommodate the development of a U-Haul self-storage, truck/trailer sharing, related retail sales, and covered canopies.

By providing opportunities for citizen participation, the applicant has ensured that neighbors had adequate opportunity to learn about and comment on the proposed plan.

### **Meeting Notes:**

U-Haul's local area president presented the project in the multi-purpose room at the City's Community Center. The only attendant was Luke Morris, City Planning Division Manager.




