Adopt Resolution No. 17-3167 Ratifying Submission of a Grant Application with the Arizona Department of Public Safety for Victim Advocate Services for 2017-2020 and Authorizing Execution of Documents and Implementation of Funded Activities

**FUNDING SOURCE:**

Grant

**PURPOSE:**

Adopt resolution ratifying submission of an application for Victim Assistance Program grant funding in the amounts of \$18,911, \$20,762, and \$22,696 for Fiscal Years 17/18, 18/19, and 19/20, respectively.

**BACKGROUND:**

The Arizona Department of Public Safety makes federal funds available to various governmental agencies for victim advocacy projects. The City Attorney’s office applied for a three-year grant for \$18,911, \$20,762 and \$22,696 for Fiscal Years 2017-18, 18-19, and 19-20, respectively. These funds will be used to offset the general fund expenses related to the Victim Services Specialist Position, which provides services to victims of crimes.

**COMMUNITY IMPACT:**

The Victim Services Specialist provides assistance to victims of crimes in Lake Havasu City.

**FISCAL IMPACT:**

The Arizona Department of Public Safety grant in the amounts of \$18,911, \$20,762, and \$22,696 will offset the general fund expenses related to the Victim Services Specialist position in the City Attorney's budget (FY 2017-2018, 2018-2019 and 2019-2020, respectively).
